## Program Description

On September 28, 2016, the Centers for Medicare & Medicaid Services (CMS) revised requirements for Long Term Care (LTC) facilities. These regulations became effective on November 28, 2016, with a three-part implementation phase-in over the next three years. The requirements include the minimum health and safety standards that facilities must meet to participate in Medicaid and Medicare. The implementation date for Phase 2 of the revisions is November 28, 2017. This program will focus on the revised Interpretive Guidance which includes clarifications to existing requirements, guidance for new Phase 2 requirements, and references to the revised survey process and protocols.

**Note: This program will not focus on the changes to the new revised survey process. There will be a seminar on the new Survey Process on October 5, 2017 at the Boxboro Regency Hotel in Boxboro.**



## Objectives

- 1) Identify the significant changes in the new revised regulations;
- 2) Know what is required in the three phases of implementation; and,
