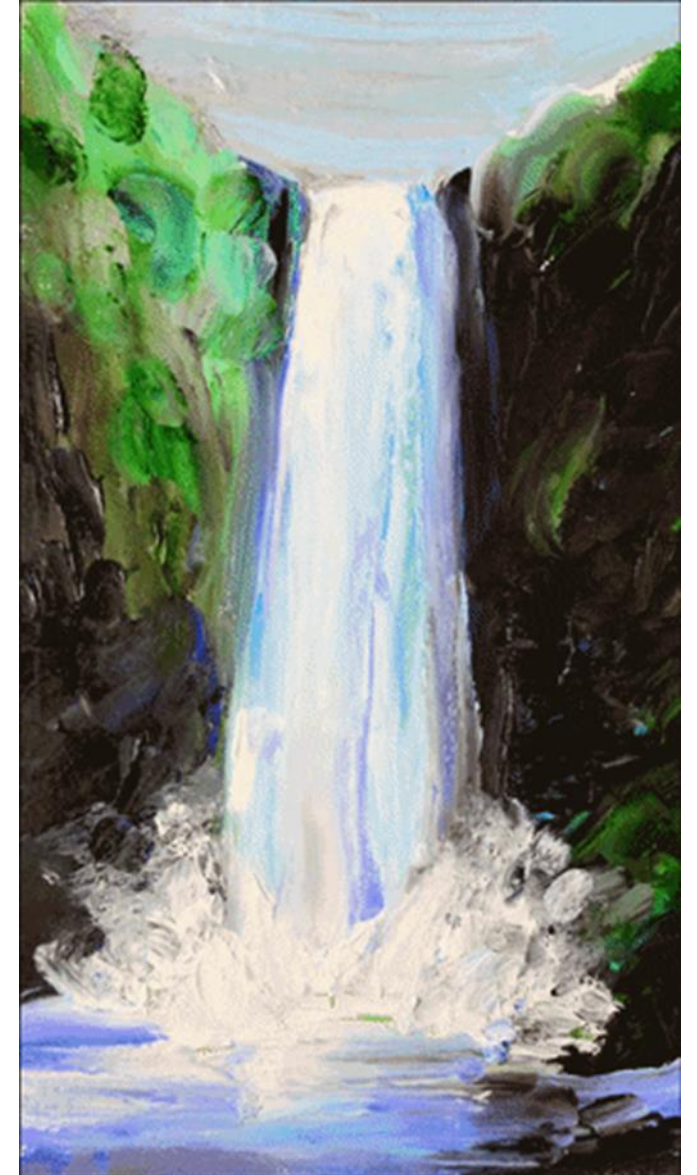

# Comprehensive Step By Step Planning Tool

## Coronavirus Disease 2019 (COVID-19) Preparedness Checklist for Nursing Homes and other Long-Term Care Settings



Nursing homes and other long-term care facilities can take steps to assess and improve their preparedness for responding to coronavirus disease 2019 (COVID-19). Each facility will need to adapt this checklist to meet its needs and circumstances based on differences among facilities (e.g., patient/resident characteristics, facility size, scope of services, hospital affiliation). This checklist should be used as one tool in developing a comprehensive COVID-19 response plan. Additional information can be found at [www.cdc.gov/COVID-19](https://www.cdc.gov/COVID-19). Information from state, local, tribal, and territorial health departments, emergency management agencies/authorities, and trade organizations should be incorporated into the facility's COVID-19 plan. Comprehensive COVID-19 planning can also help facilities plan for other emergency situations.

# COVID Resurgence Plan Components

Component	Example
1. Structure for Planning and Decision Making	<ul style="list-style-type: none"><li>-A multidisciplinary planning committee or team</li><li>-Specific individuals assigned responsibility</li></ul>
2. Development of a Written COVID Plan	<ul style="list-style-type: none"><li>-Includes relevant sections of federal, state, regional, or local plans for COVID-19 ----</li><li>Identifies the person(s) authorized to implement the plan and the organizational structure that will be used.</li></ul>
3. General	<ul style="list-style-type: none"><li>-System to monitor for the development of COVID-19 among residents and healthcare personnel (HCP) in the facility. Information from this monitoring system is used to implement prevention interventions (e.g., isolation, cohorting)</li></ul>
4. Facility Communications	<ul style="list-style-type: none"><li>-External-public health points of contact during a COVID-19 outbreak</li><li>-Internal-staff, residents, and families</li></ul>
5. Supplies and Resources	<ul style="list-style-type: none"><li>-Hand sanitizer, signage, PPE, EPA registered disinfectants</li><li>-Contingency plan that includes engaging their health department when supply shortage</li></ul>

# COVID Resurgence Plan Components

Component	Example
6. Identification and Management of Ill Residents	<ul style="list-style-type: none"><li>-Symptom recognition and management</li><li>-Cohorting, hold on communal dining, activities</li><li>-Notification of public health department</li></ul>
7. Considerations about Visitors	<ul style="list-style-type: none"><li>-Criteria and protocol for when visits will be allowed</li><li>-Process for virtual visits</li></ul>
8. Occupational Health	<ul style="list-style-type: none"><li>-<b>SCREENING</b> staff and resident</li><li>-Non punitive sick leave</li></ul>
9. Education and Training	<ul style="list-style-type: none"><li>-Education and training for staff, residents and family</li><li>-Individual(s) responsible for providing training</li></ul>
10. Surge Capacity	<ul style="list-style-type: none"><li>-A contingency staffing plan has been developed</li><li>-Includes strategies for collaborating with local and regional planning and response groups</li></ul>

# Use for Planning and Real Time

## 1. Structure for planning and decision making

- COVID-19 has been incorporated into emergency management planning for the facility.
- A multidisciplinary planning committee or team\* has been created to specifically address COVID-19 preparedness planning.

# Nursing Home Incident Command

What is NHIC?

- A scalable system to manage events - big or small; planned or unplanned and events of any type including a pandemic!

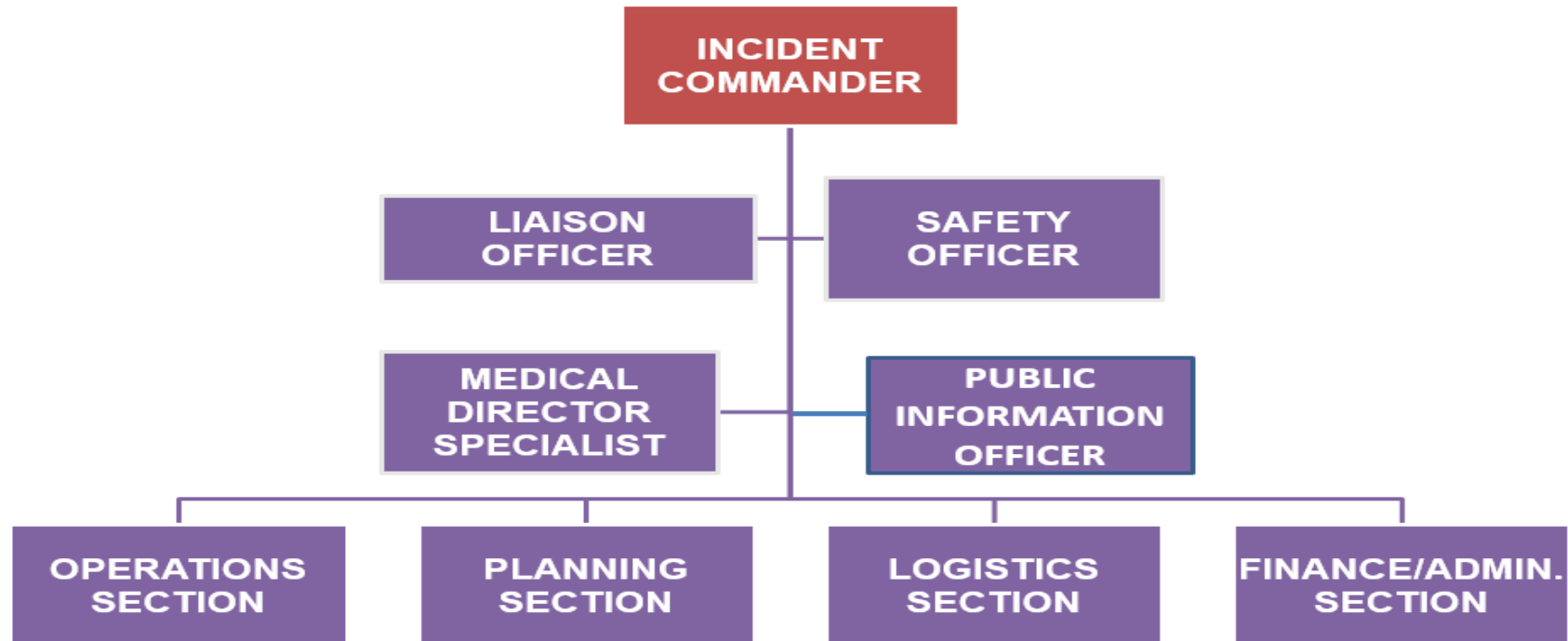
What are the Benefits of NHIC?

- Everyone gets a role in Incident Command Structure and has a clear line of authority that they fit within.
- It allows for a process that can be super-imposed on every event – full facility evacuation, a missing resident, a DPH survey and even a pandemic!
- Avoids duplication of efforts and accountability.

# Time to Review and Revise COOP Plan

A Continuity of Operations Plan (COOP) provides policy and guidance to ensure the execution of essential functions if an organization's operations is/are threatened.

Many of components that are included in your COOP plan may also be included in a COVID-19 resurgence plan:

- Incident Command Structure – may be different people for a COVID-19 resurgence plan
- Documentation – daily incident command agendas, meeting minutes, leadership briefing, floor plans for isolation & cohorting; PPE dashboards
- Staffing Plans – include staffing & HPPD dashboard
- Communications – staff, family, multiple mediums

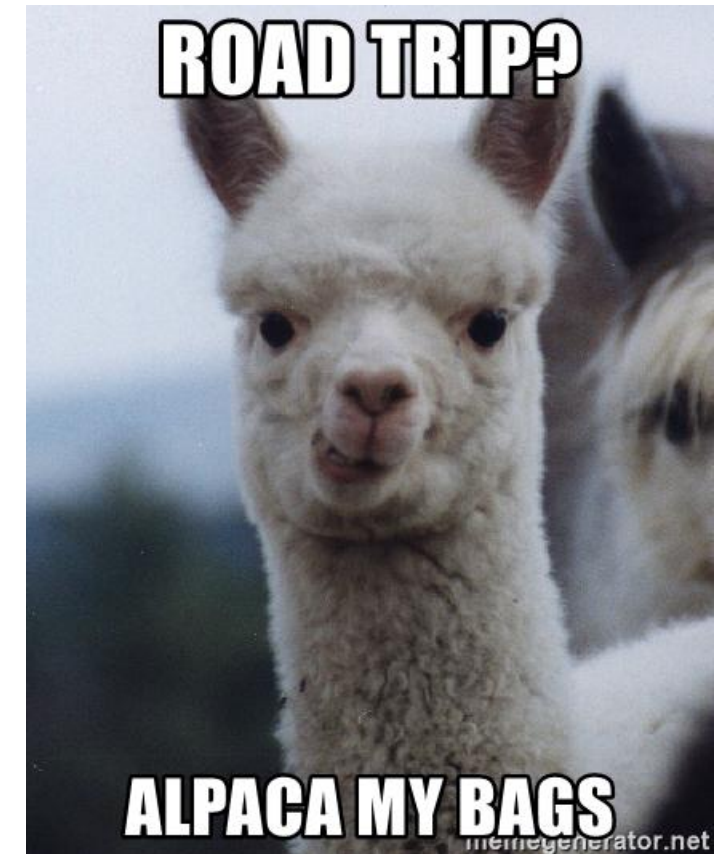
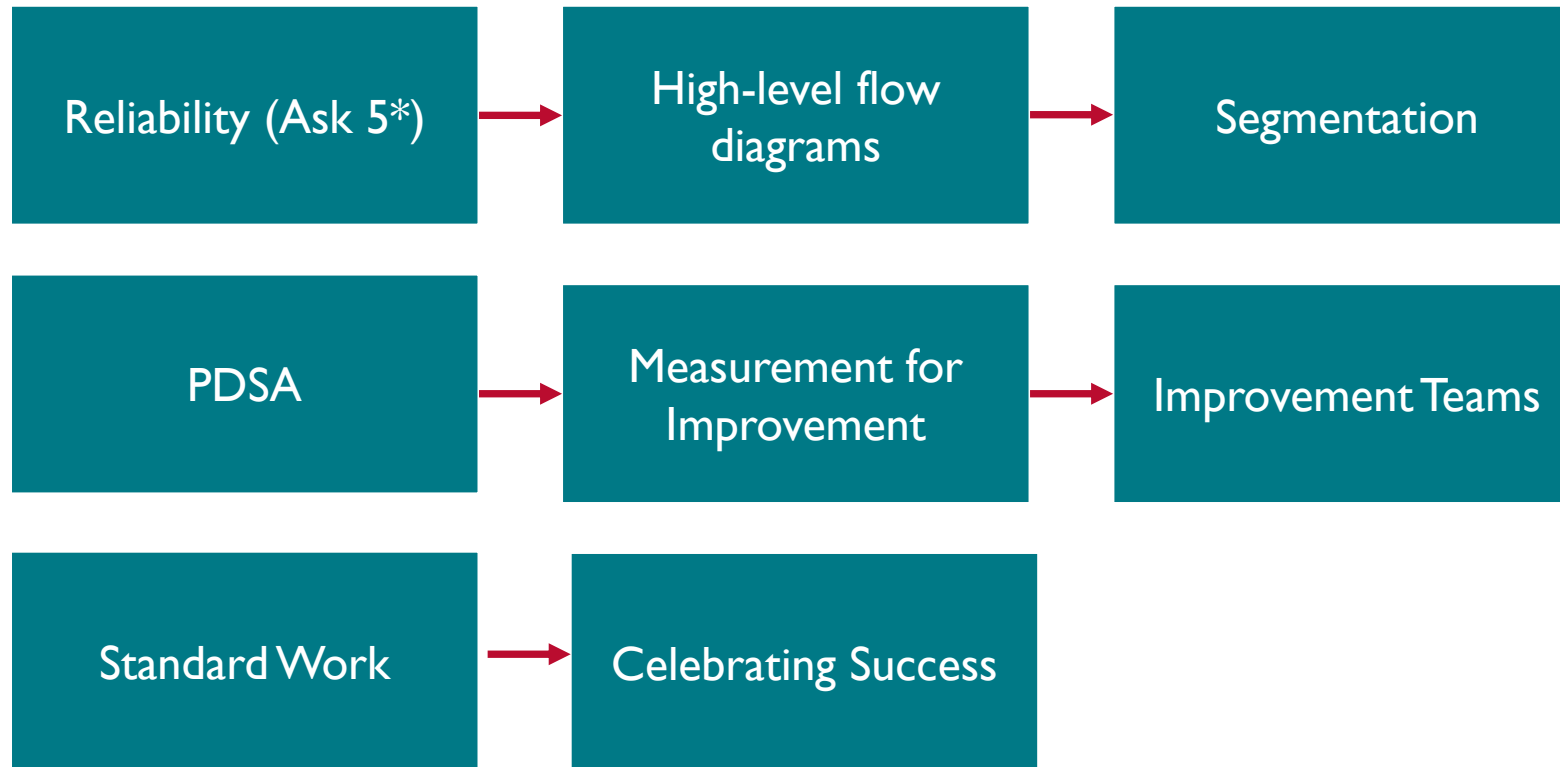

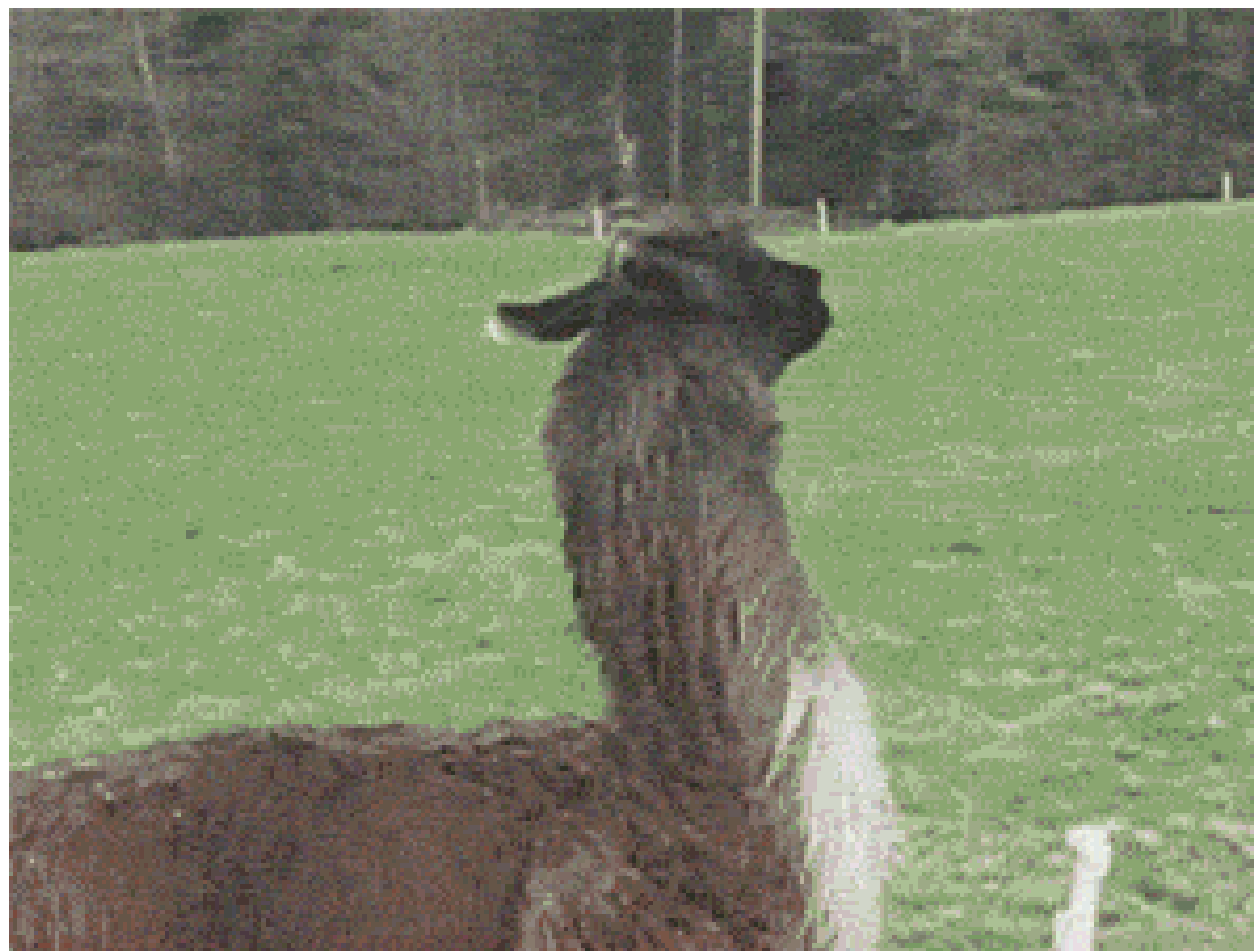
