Regulatory Compliance and Enforcement – What all Nursing Facilities Should Know!

The Department of Public Health's Leadership Team will present an overview of the Bureau of Healthcare Safety and Quality, Division of Facility Licensure & Certification organizational structure as well as review the determination of compliance with the CMS Requirements of Participation.
