Adult residents of long-term care facilities are at particular risk for severe respiratory illnesses caused by RSV, influenza and SARS-CoV-2, the virus that causes Covid-19. The residents of long-term care facilities are the ones most at risk for severe disease from these respiratory infections and the ones that will be the most affected by new vaccine availability. This webinar will inform nursing facilities of all changes to vaccine and treatments for the Fall.
